The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 11/25/2019, at approximately 0111 hours, Deputy M. Taber (ABN 256562) was parked on the side of the road when he observed a silver Toyota Corolla to be traveling westbound on W Hillsborough Ave with a taillight violation. Deputy Taber conducted a traffic stop on this vehicle at the intersection of W Hillsborough Ave and Pistol Range Rd. Upon contact with the defendant, she had glassy eyes, fumbling fingers and the distinct odor of an alcoholic beverage was emitting from her breath as she spoke. The defendant was asked to participate in the Standardized Field Sobriety Exercises, which she agreed. During the exercises, the defendant showed signs of impairment and was placed under arrest for DUI. The defendant then provided two lawful samples of her breath resulting in a BAC of .103/.103. The defendant was identified via her US passport.
