The defendant was driving a white 2017 Nissan Altima bearing a Florida license plate of L80KVU. He was traveling west on Kennedy Blvd approaching N Macdill Ave and made a wide right turn onto N Macdill Ave. The defendant then sped up to over 50 MPH in a 35 MPH zone. This was paced with my certified and calibrated vehicle for several blocks. The defendant also was weaving back and forth in his lane. A traffic stop was made and upon making contact with the defendant he displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, fumbling fingers, an odor of an alcoholic beverage, and an unsteady walk and stance. The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later refused to submit to a breath test despite acknowledgment of the Implied Consent Warning.

The defendant was identified by his NJ DL.
