The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

On 10/22/2020, at approximately 2326 hours, Affiant observed a 2014 black Dodge Ram pickup bearing FI tag DKXX89 (VIN:1C6RR6GT2ES275713) traveling north on Dale Mabry Hw N at a high rate of speed. Affiant visually estimated the speed of the Ram at approximately 60mph. Affiant then utilized a handheld laser (LTI 20/20 TRU SPEED // S/N:TS006205), which has a current calibration and was tested prior to beginning enforcement. Affiant aimed the laser at the Ram using the top mounted red dot sight and observed a tone consistent with target acquisition. Affiant observed a digital readout of 61mph in a posted 45mph zone. Affiant conducted a traffic stop on the aforementioned vehicle at Dale Mabry Hw N / Bearss Av W and observed the defendant operating the vehicle. Affiant detected signs of impairment and requested the defendant perform field sobriety exercises which the defendant agreed to perform. During the exercises, the defendant showed signs of impairment and was subsequently arrested. Post arrest, and incident to an inventory search of the Ram, Affiant located an orange prescription bottle on the passenger floor board with the label removed. Inside of the bottle Affiant observed a green leafy substance that had the odor and consistency of plant based marijuana. In addition, Affiant located an additional orange prescription bottle with a defaced label that was empty. Although the bottle was empty, Affiant detected the distinct odor of marijuana inside. Furthermore, Affiant located a small box on the front floorboard that contained a glass pipe and grinder with burnt marijuana residue. Post Miranda, the defendant identified the substance as marijuana that makes him "high." In addition, the defendant confirmed he does not possess a medical marijuana card. After a proper 20 minute observation, the defendant provided two lawful breath samples that resulted in a BrAC of .080/.080. Post Miranda, the defendant admitted to consuming approximately 2 beers and smoking the marijuana prior to driving. The defendant was identified via FL DL.
