The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did Zachary Cain was driving a gray Tesla Model 3 bearing (FL Z21EXE) that was stopped for unlawful speed of 80 MPH in a 55 MPH zone on I275 SB. The vehicle passed my patrol vehicle while my emergency lights were activated at a high rate of speed. His speed was confirmed by pace clock using car 4918 that was calibrated in July 2021. During observations Cain displayed indicators of impairment to include having red glassy eyes and the distinct odor of an alcoholic beverage on his breath. He displayed additional indicators of impairment during SFST's and was arrested for DUI. He was taken to CBT where he took the breath test. He provided breath samples of .140/.146. His identity was verified using his Florida drivers license.
