The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On the above listed date and time, at the above listed location, Deputy C Lariz (ABN 101855) made contact with the defendant during a traffic stop, after observing the vehicle speeding, swerving and driving erratically. Upon Deputy Lariz making contact with the defendant, he observed signs of impairment to include watery eyes and the odor of an alcoholic beverage on his breath. While the affiant was in contact with the defendant, I observed the defendant to have watery eyes, slurred speech, and the odor of an alcoholic beverage on his breath. The defendant spontaneously stated he consumed two beers prior to driving. Standardized Field Sobriety Exercises were conducted and impairment were observed. The defendant was arrested for DUI and provided two lawful breath samples (.137/.134 BrAC). The defendant was identified by his Florida driver's license.
