at approximately 2:08 AM, at TAMPA RD/BURBANK RD, in Pinellas County did:

REASON FOR STOP: I OBSERVED THE DEFENDANT DRIVING A SILVER TOYOTA TUNDRA BEARING FLORIDA TAG JTM-P83 TRAVELING EASTBOUND ON TAMPA RD APPROACHING BURBANK RD. I OBSERVED THE VEHICLE TO HAVE ONLY 1 OPERATING TAIL LIGHT ON THE (REAR RIGHT PASSENGER). WHILE I WAS OBSERVING THE VEHICLES DRIVING PATTERN I OBSERVED THE VEHICLE SPEEDING, PACED AT 60 MPH IN A 45 MPH ZONE. THE VEHICLE HAD DIFFICULTY MAINTAINING A SINGLE LANE.

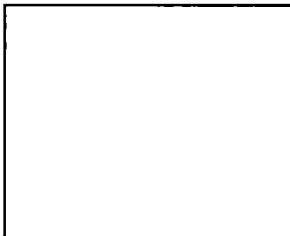
