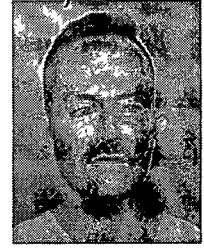

Probable Cause Affidavit

Before me this date personally appeared PLUNSKÉ DANIEL (293) who being first duly sworn deposes and says that on 16 day of October, (year) 2021 at [redacted] (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

On 10/16/21 Officers were called to [redacted] Dr by [redacted] (Victim) who stated his partner stuck him in the face Upon arrival, contact was made with [redacted] who had a visible laceration to his top lip, which had blood coming from the injury [redacted] stated he would not talk to the police and wanted his lawyer. [redacted] also declined assistance from EMS

Contact was made defendant (Aaron Taber) who stated the two are domestic partners, for two years but are not married Taber advised they just came back from dinner with friends, but would not provide details of what transpired inside the residence or how [redacted] obtained the injury to his lip Taber had visible fresh blood splatter on his shirt and hands

[redacted] was very uncooperative with police and would not provide a statement to allow pictures of his injury, and declined to press charges against Taber
