<p>The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 03/19/2022, near the intersection of North US Highway 301 and East Fowler Avenue, Thonotosassa, Florida 33592 the affiant observed the defendant operating a white 2011 Nissan Altima bearing Florida tag 134QAE with an assigned VIN of 1N4AL2AP0BC106202 operating well above the listed speed limit (79 MPH in a 50 MPH Zone). Upon the affiant's contact with the defendant, at the driver side window, I observed multiple indicators of impairment. While in direct contact with the defendant, I observed her to have watery/glassy eyes, fumbling fingers, displaced motor skills, and I smelled the strong odor of an alcoholic beverage emitting from her breath. The defendant participated in field sobriety exercises and while doing so, he demonstrated further indicators of impairment. After taking the totality of the circumstances and the defendant's indicators of impairment into consideration she was placed under arrest for DUI. The defendant refused to provided two lawful breath samples. The defendant was read Implied Consent and she continued to refuse. The defendant identified herself verbally. I further identified the defendant via her DAVID photograph.</p>
