The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
On the above listed date at 3:44 am, I arrived on the scene of a traffic collision involving an Audi car and Honda SUV on northbound I-75 near Bruce B Downs Blvd. During HSMV crash investigation 89575800, the driver of the Honda SUV identified Mr. Adam A. Tooley (later identified by FL DL) as the sole occupant and driver of the Audi car. During my interview with Mr. Tooley, he slurred his words, had bloodshot and glossy eyes, had trouble maintaining his balance while standing, and had the odor of an alcoholic beverage coming from his breath. I changed hats, advised Miranda, and initiated a criminal investigation for suspicion of DUI. Mr. Tooley agreed to perform Standardized Field Sobriety Exercises and performed poorly. Due to the totality of the observations I had to that point, I determined Mr. Tooley was impaired beyond normal faculties for operating a motor vehicle and placed him under arrest for DUI with property damage. Mr. Tooley was transported to the HCSO Orient Road jail facility. While in the Central Breath Testing (CBT) recorded room, I requested a lawful breath sample and Mr. Tooley refused. I read the implied consent warning, and again Mr. Tooley refused to provide a breath sample. The above events took place in Hillsborough County, FL.
