The defendant was driving a 1998 brown Jeep SUV bearing a Illinois license plate of N545015. He was traveling south on Armenia and was weaving back and forth. A traffic stop was made and upon making contact with the defendant he displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, an odor of an alcoholic beverage, and an admission to consuming alcohol. The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later submitted to a breath test which had a BrAC result of .194 and .190.
