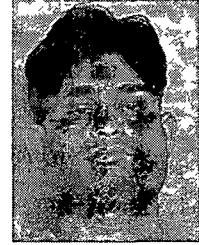

Probable Cause Affidavit

Before me this date personally appeared **EUGENE, MIKE (1025)** who being first duly sworn deposes and says that on **17** day of **March**, (year) **2022** at (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

Food was on the walls and floor, and furniture was flipped upside down. There was a pair of scissors on the kitchen island, and the furniture was cut up and all over the floor.

I met with the offender, Adarsh Verma, who said he has been married to his wife, for one year. When he arrived home from work, he walked to his bedroom and laid on his bed to go to sleep. followed him to his bedroom, and began to question him about infidelity. Verma ignored and continued to lay in bed. continued to question him and attempted to wake him up by poking him. Verma became upset, got out of bed, and grabbed her by her right arm with his left hand. Verma turned her around and began to punch her on her lower pack several times with his right fist. then turned around, used her fingernails, and scratched Verma on his arms, chest, and neck. was able to pull away and they became separated.

I then met with , who was visually upset and crying. She said, Verma came home and walked into his bedroom and went to sleep. She walked into the bedroom and began asking her husband questions. He became upset, got out of his bed, and grabbed her right wrist. He then turned her around and began to hit her on her back. She turned around and began to scratch him to get away from him. She was able to pull away and separate herself from him. Verma then went into the living room, and used scissors to cut and flip over all the furniture and began smashing cups and plates on the floor. I observed a scratch on 's right arm consistent with her statement.

I also observed scratches on Verma's right arm, the right side of his chest, and neck. signed a Victim Affidavit desiring to not prosecute. Based on my observation and the statements made, I believe Verma committed the act of Simple Battery Domestic and I
