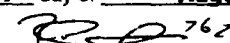

Upon arrival, I met with the victim outside the front door where he advised that he was watching television in the living room and heard crying coming from [REDACTED] room. The victim explained that he walked upstairs, entered the bedroom, and observed Adra and [REDACTED] laying in the bed. The victim stated that after asking [REDACTED] "what's going on," [REDACTED] told him that, [REDACTED] slapped me in the face." The victim advised that he told Adra that if she ever hits [REDACTED] again, "there is going to be a problem." The victim explained at that point, Adra stood up out of bed and punched him with her right hand, in a closed fist, and struck him on the left side of his mouth. The victim stated that after he tasted blood in his mouth, he walked to the master bathroom down the hall and observed that he was actively bleeding from his lip. The victim continued and said that he walked back to [REDACTED] bedroom and told Adra that he was going to call the police. The victim advised that he started to walk back to the master bedroom and was stopped by [REDACTED] who told him not to call the police on [REDACTED]. The victim said he continued to the master bathroom and was followed by Adra and [REDACTED]. The victim explained that Adra placed [REDACTED] outside the bathroom and closed the door. The victim stated that Adra grabbed his neck with both hands and told him that, "if you ever tell me (something with [REDACTED] I will fucking kill you." The victim advised that Adra struck him two more times in the face while yelling and "ranting" at him. The victim also noted that during the altercation in the bathroom, Adra grabbed him by the testicles. The victim concluded that Adra calmed down immediately after she saw the blood on his face and went back to the bedroom with [REDACTED]. The victim said at that point he called the police. The victim noted that prior to police arrival, he overheard Adra tell [REDACTED] that if he tells the police what she did, she will be taken away. The victim also noted that Adra was intoxicated during this incident.

I observed multiple lacerations on the inside of the victim bottom lip and abrasions on the right side of his neck. The victim refused any medical attention. I took pictures of the victim's injuries with my MVR.

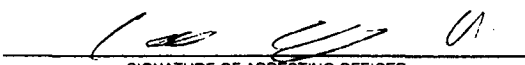
I met with Adra who advised that she did not want to give a statement about what happened. I could smell the aroma of an alcoholic beverage on Adra's breath. Adra was crying and appeared to be very upset. I explained that I was going to have to base my investigation off the victim's statement if she does not cooperate. Adra continued to be uncooperative, but she denied the allegations of striking the victim or [REDACTED]. I was unable to get a full statement from Adra. I did not observe any marks or injuries on Adra.

I met with [REDACTED] in his bedroom where he advised that he did not want Adra to get in trouble. [REDACTED] stated that Adra did not hit him. [REDACTED] said that Adra hit the victim while they were arguing in his bedroom. It should be noted that due to his young age it was difficult for [REDACTED] to give a full detailed statement about what started the altercation. I did not observe any marks or injuries on [REDACTED].

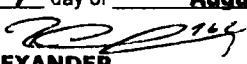
Based on the above information and investigation conducted, probable cause exists to charge Adra Cantor with Simple Battery as per FSS 784.03(1A1). Adra was placed in handcuffs which were checked for proper fit and double-locked. The victim completed a Marsy's Law form and issued her a domestic violence victim's pamphlet. I transported Adra to PBCJ where she was turned over to PBSO custody.
