yelling the "dad is fighting". North Communication advised the caller hung up the phone and would not answer the phone after North Communication tried calling back.

Upon my arrival, I made contact with a white male who was 6' approximately 170lbs in the front of the residence. He appeared shaken up and upset. He was later identified as Michael David Thompson (W/M - 01/24/1972). Michael advised he picked up his son, Aiden M Thompson (W/M - 02/15/2004) from a marina in Jupiter, FL and was dropping him off at Aiden's residence (3446 W. Mallory Blvd, Jupiter). Michael advised Aiden was very intoxicated when he picked him up. Michael advised he is divorced from Allison K Berkery (W/F - 05/28/1974) and he currently resides at (4162 Stadium Dr., Jupiter). Michael advised when they got to the residence, they both entered the house and Aiden began crying. Michael advised he was comforting Aiden and giving him a hug because he was leaving. Michael advised when he gave Aiden a hug, Aiden yelled "get the fuck off me!" and became belligerent. Michael advised he tried to calm Aiden down; however, Aiden became more irate. Michael advised Aiden ran and punched a hole in the wall in the hall way. Michael advised he wanted to stop Aiden from destroying the residence and possibly hurting himself or anyone else. Michael advised Aiden was not being coherent and was going to punch more holes in the wall. Michael advised he tried to restrain Aiden and calm him down.

Michael advised they went into the bedroom and Michael let go of Aiden once he started to calm down. Michael advised he thought Aiden calmed down and was relaxed. He advised he turned around and began to leave the bedroom. Michael advised Aiden then grabbed Michael from behind and placed him in a headlock. Michael advised Aiden placed his right arm around Michael's neck and forcefully brought him to the ground. Michael advised he was being choked and he felt he was in the choke hold for approximately thirty seconds to a minute. Michael advised he did not try to move too much because he was getting tired and feared he would pass out.

He advised his other son, Austin J Thompson (W/M - 03/17/2002) and Allison walked into the bedroom and pulled Aiden off of him. Michael advised after Aiden was pulled off of him, Aiden began to walk towards the kitchen and yell. Michael advised it appeared Aiden was trying to grab a knife from the kitchen. Michael stated he tried to restrain Aiden and Allison came in the kitchen and calmed Aiden down.

Michael advised Austin and he walked outside the front of the residence and Allison was inside the residence calming down Aiden. Michael advised Austin opened the front door and when Aiden saw him (Michael), Aiden rushed towards Michael and tried to tackle him. Michael advised it was a failed attempt and Austin was able to return Aiden back in the residence. Michael advised Allison told him to call the police.

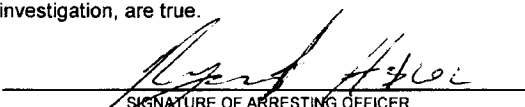
Michael advised this is the first time he seen Aiden in this state. He advised Aiden may have smoked marijuana and was intoxicated as well as having anger issues. He advised he has seen Aiden intoxicated; however, not violent.

As I was speaking with Michael, yelling could be heard coming from inside the residence. PFC. Schneider, Officer Jurac and I entered the residence. Aiden was sitting down on the floor in the kitchen and Austin was hugging him trying to calm him down. PFC. Schneider and Officer Jurac placed Aiden into handcuffs which were double locked and checked for tightness.

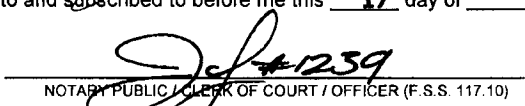
I spoke to Austin who appeared calm and made a statement that was consistent with Michael's statement. Austin advised Michael picked up Aiden from the marina. He advised when Michael and Aiden arrived at the residence (3446 W. Mallory Blvd), Aiden broke down crying when he saw Allison. Austin advised Aiden was calm; however,

N A R R A T I V E	started to get angry. Austin advised Aiden stated "I hate my dad", "I want to hurt him" and "I'm going to hit dad". Austin advised Michael walked into the front door of the residence. Austin advised Aiden was angry and punched a hole in the wall. Austin advised Michael was trying to calm Aiden down. Austin advised Michael and he attempted to restrain Aiden in his bedroom. Austin advised Allison and he got Aiden off of Michael. Austin advised Allison calmed Aiden down while Michael and he walked outside. Austin advised he entered the residence and Aiden got angry when he saw Michael standing outside. Austin advised Aiden attempted to tackle Michael; however, was not able to. Austin advised Allison and he went inside the residence with Aiden and calmed him down. I made contact with Allison who appeared upset and confused. She advised Michael went to the marina to pick up Aiden because he got in trouble there. Allison advised when they arrived at the residence, Aiden walked inside and started to cry. She advised when Michael walked inside the residence to say he was leaving, Aiden started acting "bat shit". She advised Aiden started to yell and get angry. Allison advised she was still in shock and could not remember the entire incident. Allison advised this was the first time this has happened. While in the holding cell at the Jupiter Police Department, Aiden advised Michael struck him first; however, he would not go into more detail about the incident and refused to talk about it. Based on the aforementioned investigation, I advised Aiden he was being placed under arrest for domestic battery. During my investigation, I observed Aiden who appeared intoxicated and was approximately 5'10 and 170lb. He was sweating profusely and his chest was red. He also had glassy eyes and slurred speech. I also observed Michael, Aiden and Austin had injuries. All parties refused the assistance of Palm Beach County Fire Rescue. Michael's face and neck were red, and he had scratches on his left knee. Aiden had scratches on the knuckles of his right hand. Austin was recovering from an injury to his right ankle unrelated to this incident. I issued Michael a Domestic Violence Brochure and advised him to contact the Jupiter Police Department if he had any questions or concerns. I also took pictures of Michael and Aiden's injuries and uploaded them to Evidence.com. Aiden was transported to the Jupiter Police Department for processing and later transported to Palm Beach County Jail without further incident. Based on my investigation, I found probable cause to arrest Aiden M Thompson for Domestic battery by strangulation contrary to Florida Statute 784.041 (2) (a).
