The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: K9 Ofc M. Peworchik observed a silver Dodge Charger run a couple of red lights on West Shore Bl and lost track of it due to its high rate of speed. TPD Air 7 located the vehicle and gave updates on its location. Ofc Peworchik stopped the vehicle bearing (FL 33BDKS) after it ran the red light at S Tampa St / W Brorein St. He made contact with the driver, Alec Moniz, and observed him display indicators of impairment. Moniz's eyes were red and glassy, his speech was slurred, and there was the distinct odor of an alcoholic beverage on his breath and there was the odor of burnt marijuana on his person. He displayed additional indicators of impairment during SFSs and was arrested for DUI. He was advised of implied consent before he was taken to CBT where he refused breath. Moniz's identity was verified using his state of Florida driver's license.
