Before me this date personally appeared BOHM, JONATHAN H (1555) who being first duly sworn deposes and says that on 1 day of April, (year) 2022 at 900 N FT LAUDERDALE BCH BLVD, FORT LAUDERDALE, FL 33304 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows
witnesses and officers on scene reported the driver showed signs of impairment

Upon arrival, I spoke to Officer Lopez on scene to obtain the incident and driver information (see officers supplement for further information) Officer Lopez advised that the driver was unsteady on her feet, had slurred speech, and a short attention span I then contacted Alena Lesina while she was standing on the sidewalk I asked her to walk over to my vehicle so we could talk While walking she seemed unsteady and unable to walk straight I advised her that the traffic crash investigation was complete, and I was now conducting a criminal D U I investigation While speaking with her, I noticed she swayed while standing, had blood shot / watery eyes, slurred speech (with accent) and there was an obvious odor of an alcoholic beverage coming from their breath and person I asked if she was willing to perform Standardized Field Sobriety Tasks (SFST's) and she agreed to perform the exercises

Prior to beginning any tasks, I asked the following questions

Are you sick or injured No
Do you diabetic or epileptic No
Do you take insulin No
Are you under the care of a doctor or dentist. No
Do you have an injuries No
Are you taking any medications No
Do you have any physical handicap No

Before me this date personally appeared BOHM, JONATHAN H (1555) who being first duly sworn deposes and says that on 1 day of April (year) 2022 at 900 N FT LAUDERDALE BCH BLVD, FORT LAUDERDALE, FL 33304 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

HGN (Clues 6/6)

(Equal pupil size / equal tracking / no resting nystagmus)

She had a lack of smooth pursuit in both eyes, Distinct Nystagmus at maximum deviation, and onset prior to 45 degrees. She also swayed while standing for the exercise

Walk and Turn (Clues 6/8)

She was unsteady on her feet and swayed during instructions, stopped before finished, missed heel to toe, stepped off the line, made an improper turn, and walked an incorrect number of steps (10-17)

One leg stand (Clues 4/4)

She swayed while standing, raised arms for balance, started hopping, and dropped her foot

At this time, due to the officer statements, my observations of SFST's, and the obvious odor of an alcoholic beverage, I believed her normal faculties were impaired by the alcohol she consumed and placed her under arrest for DUI I advised her of the Florida Implied Consent law, and she agreed to take a breath test I then transported her to BSO BAT where she provided two breath samples Results were .195 and 194 At the time, I transported her to BSO main jail under listed charges

- 1 DUI 1st Offense
- 2 DUI property damage
