When I asked what church she attended she just blankly stared at me. I then asked again and she stuttered multiple times before attempting an answer which I could not comprehend. I then asked where she went after church, and she advised home. When I asked where she was heading now, she also advised home. I asked Finck out of her vehicle, where she struggled with the handle for approximately 10 seconds before figuring out how to unlock the door and used the open area of the window to support herself. I then asked Finck to walk to the sidewalk for me, approximately 10 feet from where her driver's door is. Finck was unsteady as she walked to the sidewalk.

DRIVER'S STATEMENTS:

Stated she was coming from church, when I asked when that was she advised two hours ago. When I asked where she went after church she advised home, and when I asked where she was heading, she stated home. She later advised she obviously came from church because she was wearing her church dress, but continued on to advise she left church earlier and went home and changed.

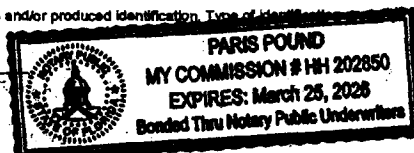

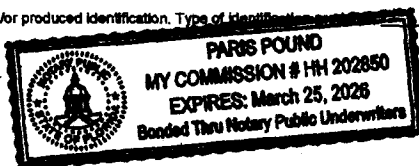

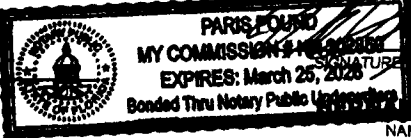

At this time I made contact with Finck, the driver and sole occupant of the vehicle, who Police Officer Davis had previously identified by her Florida Driver's License.

Finck to place her hands down by her side and her feet together how I was demonstrating at the time. Finck placed her heels approximately 4 inches apart with her toes pointed out and her hands down by her side. Finck immediately began to sway, and took a step to stay upright. I then repeated for Finck to place her hands by her side and put her feet together. Finck once again was unable to place her feet together, and advised me that she does not know if her feet are touching each other or not. This repeated 3 more times, for a total of 5 requests. I then proceeded with my Horizontal Gaze Nystagmus task while her feet were apart. Finck followed the tip of my pen with her head, turning it completely to the left. I advised her to keep her head straight, which caused her to once again sway and almost fall over, grabbing my arm for support. I advised Finck that we can go to the next task, and was about to demonstrate and explain the walk and turn. Before I could begin, Finck was interruptive stating that it was too hot and she has to go home. She advised me multiple times to just follow her home. Finck then almost fell over again, this time grabbing my left arm and quickly taking a series of small steps to avoid falling. I then grabbed Finck's arm to support her, and placed her in double locked handcuffs checked for tightness. Based on my investigation and observations of Finck's standardized field sobriety tasks and failure to be able to complete them due to her severe impairment and risk of injury, she was placed under arrest for driving under the influence, contrary to F.S. 316.193(1). At the time of the arrest Finck was wearing a white dress with blue and pink accents. Finck was then transported to the Palm Beach Sheriff's Office Breath Alcohol Testing Center (B.A.T.). It should be noted that while transporting Finck to the B.A.T. she was hostile with me, telling me multiple times to "shut the fuck up" and that if I "do not stop the car right now, she is going to call the cops". Finck asked me during the ride if I could just turn around and drive her home, and that she was going to arrest me if I didn't. Finck's breath sample was not taken on camera due to a refusal. I called a refusal due to the subject's initial response that she would not blow, and then also advised her husband always told her not to blow if she was ever asked to. Finck was processed at the B.A.T. and later booked into Palm Beach County Jail.
