The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was operating a black 2010 Lincoln MK7, 4 door SUV, Florida tag Z644ML. The defendant was stopped for unlawful speed. The defendant was traveling at 81 MPH in a properly posted 55 MPH speed limit, which was visually estimated and confirmed via Laser Technology TruSpeed LR laser, serial number TS007017. When the traffic stop was initiated using patrol car emergency lights, emergency siren, and exterior spot light, the defendant was extremely slow to react to, or respond appropriately to the signal given to stop. The defendant passed multiple locations where he could have easily stopped. The defendant had a distinct odor of an alcoholic beverage coming from his breath. The defendant's eyes were bloodshot, glassy, and watery. The defendant's face was flushed. The defendant's speech was mildly slurred. The defendant was wearing a Tampa Bay Lightning hockey jersey, and had been coming from Amalie Arena. The defendant stated he drank two beers tonight. The defendant searched aimlessly through documents without seeming to focus, picking up the same documents repeatedly, and the defendant was easily distracted, displaying an inability to multi-task. The defendant swayed mildly while standing. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and based on a totality of the circumstances the defendant was arrested for DUI. The defendant refused to submit to a lawful test of his breath for the purpose of determining its alcohol content after he was advised of the Implied Consent Warnings. The defendant was positively identified by his Florida DL.
