On the 11 day of August, 2022 at 02:58 (Specifically include facts constituting cause for arrest) The following crime was committed in the city of Delray Beach, Palm Beach County Florida. On 8/11/2022, I was on routine patrol at 29 SE 2nd Avenue (Throw Social) when I could hear footsteps banging off the roof rear of the Throw Social. While walking back to investigate the sounds I observed one White Male subject on the roof of the rear building (Axe Throwing) complex inside Throw Social. Ofc Smith (ID 1016) and I walked the perimeter of Throw Social where we observed two White Males matching the description of the subjects on the roof. The two individuals were identified as WM David B. Machluf (FL DL M241162021000) (DOB: 3/20/2002) and Alexander T. Rodriguez (FL DL R362018014270) (DOB: 11/27/2001) by their Florida Drivers Licenses. At this time the two White Male Subjects were detained pending questioning of the General Manager Nicolas Espier to see if these individuals had permission to be on the property. Espier stated that they did not have permission to be on the property after closing hours of Throw Social, wanted to press charges for burglary and issue a trespass order to both subjects. While conducting a search incident to arrest Rodriguez was found to be in possession of a Fake Florida Driver's license within his property. Machluf was found to be in possession of another subjects FL Driver's License which would have made him to be over 21 years old. I have probable cause to charge David B. Machluf with one count of Burglary to an Occupied Structure per FSS 810.02(3)(C), one count of 817.568(2)(A) USE/POSSESS OR USE ANOTHER Identification card of another individual for personal use. I have probable cause to charge Alexander T. Rodriguez with one count of Burglary to an Occupied Structure per FSS 810.02(3)(C) and one count of Possession of Forged/Counterfeit Driver's License per FSS 322.212(1).
