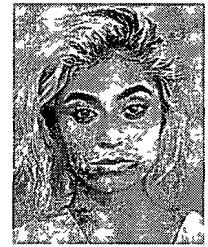

Probable Cause Affidavit

Before me this date personally appeared STRUNK, JOHN (829) who being first duly sworn deposes and says that on 22 day of September, (year) 2017 at 3301 COLLEGE AVE, DAVIE, FL 33314 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

observed the defendant's vehicle stopped in the travel lane of the parking lot The defendant's vehicle also displayed an expired Florida license plate At that time the defendant was still seated in the driver's seat of the above vehicle The vehicle was running but not in gear Sgt Cuneo made contact with the vehicle that was sounding the horn and the male said that he was honking at the female that refused to move her car. The male told Sgt Cuneo that he thought that the female was drunk. Sgt Cuneo made contact with the driver who he observed to have bloodshot glassy eyes and he detected an odor of and alcoholic beverage coming from the vehicle

The location of the stop was on the campus of Nova Southeastern University (NSU) near Vettle Hall This property is policed by the Davie Police Department and the school has given the Davie Police Dept signed rights to conduct traffic enforcement. The defendant only had access to this area deep within the campus because the security gates are malfunctioning due to the recent hurricane Normally, someone who does not possess NSU campus ID could not come into this lot I arrived and asked the driver if she was ok She kept yelling at someone on the phone saying that she couldn't talk. She seemed to be between crying and laughing when I asked her to hang up the phone I asked her if she was a student of the school and she said no She seemed confused by my question and kept looking around I asked her if she had NSU identification and she said no I asked her why she was at this location and she said, "I'm here to visit a friend." I asked her for the name of her friend and she said Chelsea She did not know her last name, room number and/or what building she lives in Throughout this time the defendant had slurred speech. I also noted the odor of an alcoholic beverage coming from her breath as she spoke as well as the bloodshot & glassy eyes

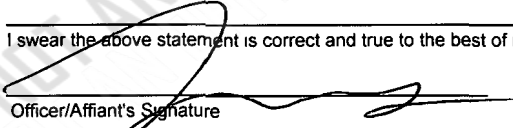
Before me this date personally appeared STRUNK, JOHN (829) who being first duly sworn deposes and says that on 22 day of September, (year) 2017 at 3301 COLLEGE AVE, DAVIE, FL 33314 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

I asked the defendant to step out of the vehicle and she did so very slow and deliberately. When she exited the vehicle I asked her if she had been drinking and she said yes. She told me that she had one glass of wine at "the boatyard". I asked her if that is where she was coming from and she said yes. Now she told me that she was on her way home to Pembroke Pines. After having an entire discussion about being at NSU I asked her if she knew where she was and she said no. We were standing directly next to a marked security vehicle that plainly said "Nova Southeastern University" but the defendant still was not sure of where she was. I told the defendant that based on my physical observations of her, her admission to having consumed alcohol (she is under 21 years old), and her own statements, I believed that she was in actual physical control of a motor vehicle while under the influence of alcohol and/or drugs. The defendant interrupted me and said, "you are correct, I have been drinking and I'm only 85 pounds so it doesn't take much for it to hit me". I asked the defendant to take part in voluntary roadside sobriety exercises. She said that she would not. I told her that the exercises were indeed voluntary but if she did not take part in them I could only base my decision to make an arrest based on what I have learned so far. She said that she would do "whatever I wanted". I asked her to answer with a yes or no. She said no. I placed the defendant under arrest for DUI because I believe that she was in actual physical control of a motor vehicle while intoxicated to the point that her normal faculties were impaired.

I asked the defendant to submit to a test of her breath for the purpose of determining it's alcohol content and she said yes. I transported the defendant to the Davie Police Station for processing where Ofc. Cain #711 met me to conduct the breath test. Ofc. Cain later provided me with a breath test affidavit indicating the results of 172 &
