I asked her for the name of her friend and she said Chelsea She did not know her last name, room number and/or what building she lives in Throughout this time the defendant had slurred speech. I also noted the odor of an alcoholic beverage coming from her breath as she spoke as well as the bloodshot & glassy eyes
