On 02/25/21, I was assigned a harassment case as a follow up investigation that was reported on 02/23/21 by the complainant, [REDACTED]. The following is a synopsis of the initial report completed by Boca Raton Police Department Officer Desiderato: [REDACTED] reported that she received approximately 200 text messages between 1330 and 2100 hours on 02/23/21 to her cell phone from phone number 802-345-1432. [REDACTED] explained that the messages were sent by Aline Questel, an ex-girlfriend of [REDACTED] who lives in [REDACTED]. [REDACTED] explained that she was very familiar with Questel because seven years ago Questel and [REDACTED] broke up and she harassed him and his family in the same fashion. It should be noted that Questel also sent hundreds of messages to [REDACTED] who resides in [REDACTED] from the same phone number (802-345-1432) that was the same phone number Questel used to contact [REDACTED] approximately seven years ago when they were in a relationship. The other phone number used to harass [REDACTED] was (305-998-6270), which was determined to be a number populated by Pinger Text Free application. Pinger, Inc and Microsoft Online Services were able to provide information that showed the phone number (305-998-6270) was registered to a jennifer.cruise@hotmail.com. The subscriber information for the Hotmail email account was under a false name of Daylousee Noknealeth, with no other identifying information. It should be noted, Questel identified herself as "Aline Questel" when she answered one of the text messages from [REDACTED] using the phone number (802-345-1432). [REDACTED] also sent Questel's father an email asking for him to restrain his daughter. A screenshot of this message was taken by Questel and sent to [REDACTED] stating, [REDACTED] and your fucking son stole my fucking earrings and I'm gonna need them back". Questel also continued by stating, "I hope that you don't find this text message threatening but instead a cry for help because I'm going to call the police on your fucking son for stealing my precious earrings". Refer to Delray Beach P.D. case number 21-002410. [REDACTED] advised that she was concerned for the safety of [REDACTED].

On 02/26/21, I made contact with [REDACTED] over the phone to review the facts of her case. Questel has escalated to harassing multiple friends and family of hers, so [REDACTED] decided that she would like to pursue criminal charges. Marianne stated that she told Questel to stop contacting her several times, but that has not deterred Questel's harassment.

On 03/01/21, [REDACTED] sent me screenshots of approximately 200 messages that were sent to her from Questel since 02/23/21. The messages were insistent and harassing in nature with the use of a lot of obscene language. Some of the messages sent by Questel stated, "You are going to give me back my fucking goddamn earrings or you will reimburse me or else", "Bitch", "You're a fucking thief and a cunt bitch". Questel is adamant in the text messages that [REDACTED] kept her earrings after their breakup seven years ago, but neither [REDACTED] nor [REDACTED] know what earrings Questel is referring to nor where they are now. [REDACTED] responded to Questel briefly stating, "I filed a police report against you I expect you to stop blowing up my phone and take your medication. This time I will be prosecuting I am done dealing with you also I've reached out to your father".

At one point [REDACTED] asks, "Who is this?", to which Questel responds, "Thought you emailed my father you fucking cunt". After that message Questel sends a screenshot of the email that was sent to Roger Questel (her father) from [REDACTED]. It should be noted that no one other than Aline Questel would have had a screenshot of the email sent to Roger Questel. Questel continues sending multiple harassing messages stating, "I will destroy you" and "[REDACTED] darling if I don't get back my earrings I'm going to destroy his wife, and your life, I don't give a fuck", referring to [REDACTED] wife. Questel continues stating "Those earrings are the most precious things to be you better return them or his going to suffer. You will all suffer if I don't get my precious earrings back...Those earrings are fucking precious and I will ruin your life for them. Sweetheart. I've already ruined her day. Lmafoooooooo. She got her friends even defriended her". Questel proceeded to send a screenshot she took of [REDACTED] Facebook friends list, to which she advised that she messaged all of them. Questel then advised, "Just give me back my earrings and I'll stop". Questel later sends a text message stating, "If you don't I'll destroy your reputation and you can call the police and we can get this sorted out, okey-dokey you atrocious cunt". Later on she states again, "I SWAER TO GOD AND ON EVERYTHING THAT I WILL DESTROY YOUR REPUTATION". It should be noted that Questel continued in this harassing and threatening manner for several more hours on 02/23/21, threatening to harm the family business reputation over Facebook as well. [REDACTED] was able to provide me with a comment made on [REDACTED] Facebook page, made by a "Jennifer Cruise" stating, [REDACTED]. It should be noted, Jennifer Cruise uses the same email jennifer.cruise@hotmail.com, which was found to be registered to the Pinger Text Free application account used to send harassing messages to [REDACTED]. [REDACTED] is owned by [REDACTED] and [REDACTED] can be seen as a [REDACTED] with the [REDACTED] from my training and experience, this Facebook account under the name

"Jennifer Cruise" is fake, because there are no photos or further personal information of the person on the profile and the profile only recently acquired 39 friends that do not live near each other nor have mutual friends in common. This comment was made by this fake Facebook account during the same time that Questel was harassing both [REDACTED] and [REDACTED] It should be noted that I spoke with Detective Anthony Sala from Delray Beach Police Department in reference to our related cases. Detective Anthony Sala advised that he made contact with Questel in reference to the messages she has sent to [REDACTED] and his family. Questel rambled on nonsensically and then hung up on Detective Anthony Sala. Since speaking with her on the phone, Questel sent Detective Anthony Sala approximately 28 emails in the span of one hour, threatening to find and harass him on social media sites as well. Based on my investigation, I have probable cause for the arrest of Aline Questel for extortion F.S.S. 836.05 for sending written communication, maliciously threatening to accuse [REDACTED] of a crime that threatens injury to her reputation in an attempt to disgrace [REDACTED] with the intent to extort diamond earrings or money from her against her will. Questel will also be charged with stalking per F.S.S. 784.048 (2) for willfully, maliciously, and repeatedly cyberstalking [REDACTED]
