The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On Monday, November 15, 2021, at approximately 4:00 am, at the Seminole Hard Rock Hotel and Casino - Tampa, I, Seminole Police Department (SPD) Officer A. Conran responded to the Hard Rock Hotel, Room 421, in reference to a disturbance that was reported by casino security. Upon my arrival, I made contact with other SPD Officers on scene, who advised that the disturbance was between a boyfriend and girlfriend, who reside together, which possibly turned physical. I approached and spoke with both parties involved. The male half (victim) was identified as Ben T. England, via his Florida driver's license bearing the number of E-524-078-61-408-0. England stated that he and his girlfriend have lived together for approximately two years and shared a Hard Rock hotel room on this day. England advised that, upon confronting his girlfriend about "talking" to another guy, she "freaked out" on him. England stated that by "freaking out" he meant that his girlfriend yelled, screamed and hit him. England advised that she hit him with her hands (unknown if open or fist) on his face and neck. This Officer observed England to have redness and slight swelling on the right side of his face, near his right eye, as well redness on the left side of his neck.

I then spoke with the female half (suspect), who was identified as Aleece O. Owen, via her Florida driver's license bearing the number of O500-014-86-916-0. Upon speaking with Owen, she advised that she was woken up by England and confronted about text messages on her phone. Owen was slightly argumentative and stated that she did not want to talk to me, that she wanted to go home and that she did not trust the authorities. When asked, after several times, Owen stated that she wasn't injured and this Officer did not observe any apparent physical injuries to her. Owen advised that her and England do currently reside together.

Based off of the aforementioned investigation, Aleece Owen was determined to be the primary aggressor and was placed under arrest for battery - domestic violence. She was handcuffed behind her back, checked for tightness and double locked. Owens was subsequently transported to the Orient Road Jail, without incident, where she was booked for the charge listed in this document.

Enlgand was subsequently issued a DV pamphlet.
