The defendant then continued to drive southbound on Tampa St N, and eventually stopped at Tampa St N / Tyler St E. Officers arrived on scene shortly thereafter and made contact with all parties. During the traffic crash investigation, the defendant was positively identified as the driver of the white Kia by the eyewitness (black Chrysler driver) and his passenger. Her identity was verified via a FL DL. While speaking to her, she exhibited several clues of impairment, to include: Watery/bloodshot eyes, droopy eyelids, blank/dazed stare, slurred speech, poor balance, poor coordination, appeared very tired/lethargic, made slow/deliberate movements, was emotional, walked with gait ataxia, was in possession of an opened container of alcohol, admitted post Miranda to drinking "Pickle Back Jack Daniels" prior to driving, and emitted a distinct odor of an alcoholic beverage from her breath.
