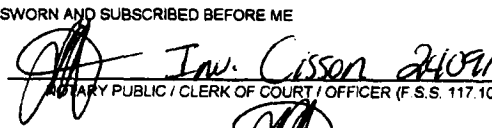
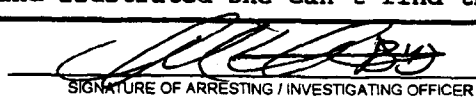

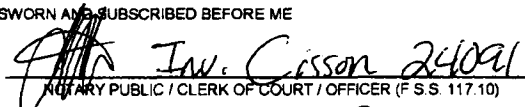

OBSERVATION OF DRIVER:

I observed the defendant, Alligsa Aristy who was wearing a green tank top, black pants, and black slides. The defendant was standing outside of her vehicle. I asked the defendant to walk over to the front of my vehicle and speak with me. While standing stationary the defendant swayed. I could see the defendants eyes were bloodshot and glossy. She had an obvious odor of an unknown alcoholic beverage emitting from her breath that grew stronger as she spoke. Post arrest, during an inventory search of her vehicle, three marijuana oil cartridges were found in the center console and in her purse. All were open out of the packaging. One was attached to a pen device. The packaging was not in the vehicle. She was in possession of a medical marijuana card. She said she also has a concealed weapons permit. After a records check, it was [REDACTED]. She did not have the weapons permit in her possession at the time of her arrest.

DRIVER'S STATEMENTS:

The defendant said she did not have any physical defects or preexisting injuries, diabetes, or receive a bump on the head. The defendant said she had mixed drink with Gin to drink. She said she had not done any drugs or smoked Marijuana. The defendant said she was coming from Clematis and going home.
