On 12-20-2022 at approximately 2222 hours, _____ responded to Renaissance Hotel located at 2000 NW 19th Street after BRPD Dispatch received a call stating that a physical domestic disturbance had occurred in room 512. Upon arrival, I entered the elevator located on the first floor, to go up to the fifth floor. As the door was closing, I was stopped by the front desk Manager, Complainant 1. Complainant 1 stated that the female half, later identified as Allison Garcia, was walking westbound down the hallway. I observed Garcia to be walking at a fast pace down the hallway barefoot, wearing a white long dress. I proceeded to walk toward Garcia, and I asked what was going on. Garcia responded "nothing". She said that she needed a room key and continued walking westbound down the hallway. I called out to Garcia by stating, "ma'am" and she stopped walking. I asked Garcia why she was walking so fast and why did we get a call, in reference to a domestic in room 512, in which she was staying in. Garcia confirmed that was her room, but nothing was going on. Garcia walked off again. I called out, "ma'am" to Garcia again and told her to come back, in which she did. Garcia stood at attention with her hands by her side and stated, "Yes sir, aye-aye sir, what do you want. "nothing is going on", and walked off once again. I called out "ma'am", as Garcia continued walking westbound down the hallway, but she did not respond. I followed her at a distance without saying anything else. Garcia turned around, clapped her hands and flailed her arms stating, "let's go, arrest me" as she approached me. Garcia placed both hands in the small of her back and faced away from me. With force, Garcia took the back side of her body and pushed into me, as she stated, "arrest me" repeatedly. In the same motion, as she pushed off me, I attempted to grab Garcia's right arm with my right hand, but she pulled away. Garcia faced me and pushed me in the chest using both of her hands. In a deflecting manner, I used both of my arms to move Garcia's arms away. I stated to Garcia to get her hands off me and I grabbed her by the right wrist utilizing my right hand and I used my left hand to place

at the top of her right shoulder. I walked her to the elevator door as she continued stating to arrest her. Garcia tensed up as I was trying to place her right hand behind her back to handcuff her right wrist using my right hand. She repeatedly attempted to turn around and I kept my left hand on the top of her right shoulder and my right hand near her right wrist. Garcia stated to not hurt her shoulder and that she would place her hands behind her back, but she still attempted to pull away with her right arm. Officer Posset arrived and gave commands to put her hands behind her back and to stop resisting. As Officer Posset held Garcia's right arm, I was able to handcuff both arms. As I was trying to adjust Garcia's handcuffs, she started to pull her left arm in an upward motion and I used my right hand to push her left elbow forward while telling her to stop, so I could make the proper adjustments to the handcuffs. Once the handcuffs were tightened on both wrist, and double locked, Garcia was walked outside toward the front door of the hotel. As we were walking, Officer Posset held Garcia's right arm and I held her left arm. Officer Posset offered medical attention from BRFD to Garcia, but she declined. Garcia was then placed in the back of my BRPD marked unit, 345. At the conclusion of this incident, Allision Garcia was charged with Battery on a Law Enforcement Officer, FSS 784.07(1D) and resisting without violence, FSS 843.02. Garcia was transported to Palm Beach County Jail.
