I swear the above statement is correct and true to the best of my knowledge and belief

who being first duly sworn deposes and says that on

2017 at 10300 W SAMPLE RD, CORAL SPRINGS, FL 33065 day of September, (year) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

LANE AGAIN. IT THEN APPROACHED ANOTHER LEFT TURN LANE AND STARTED TO ENTER THAT LANE BEFORE CORRECTING ITSELF. I REASONABLY SUSPECTED BASED ON MY TRAINING AND EXPERIENCE THAT THE VEHICLE'S DRIVING PATTERN WAS INDICATIVE THE DRIVER MAY BE IMPAIRED OR UNFIT OR THAT THE VEHICLE MAY BE DEFECTIVE. I THEN CONDUCTED A TRAFFIC STOP ON THE VEHICLE IN THE INTEREST OF PUBLIC SAFETY. IN ADDITION, THIS DRIVING PATTERN WAS EXTREMELY DANGEROUS TO THE GENERAL PUBLIC DUE TO THE CURRENT STATE OF EMERGENCY FROM HURRICANE IRMA. MANY TRAFFIC SIGNAL LIGHTS, TRAFFIC LIGHTS, AND SIGNS WERE DOWN THROUGHOUT THE CITY DUE TO THE DAMAGE. MANY SECTIONS OF ROADWAYS STILL HAD DEBRIS. ALSO, A CITYWIDE CURFEW WAS IN PLACE FROM 2200 TO 0600.

I MET WITH THE DRIVER AND SINGLE OCCUPANT OF THE VEHICLE, IDENTIFIED AS ALUISIO BARBOSA (DEFENDANT) VIA HIS FLORIDA DRIVER'S LICENSE. I COULD SMELL THE ODOR OF ALCOHOLIC BEVERAGE UPON HIS BREATH AND PERSON. HE HAD BLOODSHOT, WATERY EYES AND SLURRED SPEECH. I ASKED HIM IF EVERYTHING WAS ALRIGHT WITH HIM AND IF HE WAS HAVING A MEDICAL EMERGENCY. HE TOLD ME HE WAS NOT. I THEN ASKED HIM ABOUT HIS IMPAIRED DRIVING AND FAILURE TO MAINTAIN LANE. I QUESTIONED HIM IF HE WAS TEXTING. HE STATED HE WAS NOT HAVING A MEDICAL EMERGENCY. I HOWEVER VIEWED THAT HIS PHONE ON THE PASSENGER SEAT WAS CURRENTLY ON A CALL AND HAD BEEN CONNECTED AT THIS POINT FOR 18 MINUTES. I REQUESTED HIS LICENSE BUT HE COULD NOT IMMEDIATELY LOCATE IT. HE KEPT SEARCHING HIS POCKETS FOR IT, CHECKING THE SAME POCKETS OVER AND OVER AGAIN. HE EVENTUALLY LOCATED IT ON HIS PASSENGER SEAT IN HIS WALLET. I THEN REMINDED HIM AGAIN TO OBTAIN HIS REGISTRATION AND INSURANCE. HE NEVER LOCATED HIS INSURANCE DESPITE MY REQUEST, ONLY HIS REGISTRATION. HE TOLD ME HIS ONLY MEDICAL CONDITION WAS HIGH BLOOD PRESSURE AND SAID HE FELT FINE TO DRIVE HOME. HE DENIED HAVING DIABETES OR EPILEPSY. AT THIS POINT HE TOLD ME HE HAD NO PHYSICAL DEFECTS. BASED ON MY CONVERSATION AND OBSERVATIONS OF THE DEFENDANT, COUPLED

WITH MY TRAINING AND EXPERIENCE, I BELIEVED THE DEFENDANT WAS DRIVING IMPAIRED. I THEN ASKED IF HE WAS WILLING TO PERFORM VOLUNTARY SFSE (STANDARDIZED FIELD SOBRIETY EXERCISES) AS PART OF MY DUI INVESTIGATION. THE DEFENDANT AGREED.

PRIOR TO BEGINNING EACH EXERCISE, HE STATED HE HAD NO QUESTIONS AND THAT HE UNDERSTOOD ALL INSTRUCTIONS FOR THE EXERCISES AFTER I DEMONSTRATED AND EXPLAINED THEM TO HIM.

THE FIRST EXERCISE I ADMINISTERED WAS HORIZONTAL GAZE NYSTAGMUS. THIS EXERCISE AND THE OTHER EXERCISES WERE ADMINISTERED IN THE DRY, LIT, LEVEL ROADWAY UTILIZING A SOLID YELLOW LINE ON THE LEFT SIDE OF THE ROADWAY. FOR THIS EXERCISE, I ORIENTED THE DEFENDANT AWAY FROM ONCOMING TRAFFIC AND FACING AWAY FROM MY PATROL CAR. MY OVERHEAD FRONT EMERGENCY LIGHTS WERE ALSO TURNED OFF. THE DEFENDANT WAS NOT WEARING GLASSES. HE STATED HE HOWEVER HAS A CONTACT IN ONE EYE. I UTILIZED MY RED LIGHT-EMITTING DIODE STYLUS FOR THIS EXERCISE, WHICH THE DEFENDANT STATED HE COULD FOCUS ON AND SEE FINE. I NOTICED THE DEFENDANT HAD NO RESTING NYSTAGMUS AND EQUAL PUPIL SIZE. I THEN CHECKED FOR EQUAL TRACKING OF THE EYES, WHICH THE DEFENDANT HAD. AFTER COMPLETING THE MEDICAL RULEOUTS WITHOUT ISSUE, I CHECKED FOR LACK OF SMOOTH PURSUIT IN BOTH EYES, DISTINCT AND SUSTAINED NYSTAGMUS AT MAXIMUM DEVIATION IN BOTH EYES, AND THE ONSET OF NYSTAGMUS PRIOR TO FORTY-FIVE DEGREES IN BOTH EYES. I ESTIMATED HIS ONSET OF NYSTAGMUS AT 30 DEGREES. I RECEIVED TRAINING FOR NYSTAGMUS ONSET ANGLE OF ESTIMATION IN DRUG RECOGNITION EXPERT SCHOOL.
