

Probable Cause Affidavit

Before me this date personally appeared \_\_\_FACCINI, DAVID R. (9446)

who being first duly sworn deposes and says that on

2017 at 16299 INDIAN TRC/WESTON RD, WESTON, FL 33326 17 day of September, (year) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

vehicle drifting left of center into the inside lane and then across the outside lane and into the bicycle lane in addition to speeding 55 mph in a posted 45 zone between the 1600 & 1400 blk using unit # 6028.

Deputy Perez advised that he activated his emergency lights to effect a traffic stop and made contact with the defendant noticing that his eyes were red and glassy, an odor of alcoholic beverages on his breath and slurred speech. Deputy advised that he requested the defendant's documentation and that he presented his drivers license and registration to him. Deputy also advised that he additionally had to request his proof of insurance twice and that the defendant stated that he could not locate his "registration".

Deputy Perez also advised that the defendant stated that he needed to go home because he was out of gas (driving opposite direction to his home) and that he had explained to him that he was texting while driving and that was why he could not maintain his lane of travel.

I observed the defendant's vehicle stopped on the grassy swail of Indian Trace. I asked the defendant to exit his vehicle and upon contact with him I noticed that his eyes were glassy & bloodshot, speech appeared slurred and an odor of alcoholic beverages on his breath as he spoke.

I advised the defendant that I was conducting a DUI investigation and asked him if he would submit to roadside exercises to which he agreed to. The defendant was hesitant at first if he should perform them or not and I informed him that I could not force him

HGN: I noticed an exaggerated sway. Both eyes exhibited lack of smooth pursuit. Both eyes exhibited sustained and distinct nystagmus at maximum deviation and onset of sustained and distinct nystagmus was at approximately 35 degree's. VGN was not present. The defendant stopped & started performing this exercise at least twice before completing it.

Walk & Turn: Lost his balance one time during the Instructional Stance and prior to beginning to walk. Upon beginning the walking phase the defendant did not count out loud, he turned incorrectly appearing unsure on how to turn and while returning he stepped off to his left losing his balance on his 4th step.

Finger to Nose: Did not return his arm to his side on his first selection and on

another selection he started to raise his left arm towards his nose when I requested his right arm. A total of 6 selections were requested.

One Leg Stand: The defendant swayed during the exercise, he repeated the number 12 twice, counted backward on 17 one time, he placed his foot down on 22 losing his balance and took his eyes off of his foot twice, contrary to instructions.

I concluded my investigation formulating my opinion that the defendant was under the influence to the extent that his normal faculties were impaired placing him under arrest. I advised the defendant of his arrest and requested that he submit to the breath test. The defendant agreed to submit to testing.

I transported the defendant to T671 and while on video again I informed him of his arrest and requested that he submit to the breath test. The defendant agreed again to submit to the test again. CSA Tillman # 9075 conducted the observation and administered the breath test. Brac: .137% & .134%. I subsequently transported the defendant to the main jail for processing.

Deputy Perez utilized his BWC during my roadside investigation. Defendant had 1 PRIOR DUI CONVICTION ON DAVID
