Probable Cause Affidavit

Before me this date personally appeared CHAPPIN DUNCAN, DAVID (18797) who being first duly sworn deposes and says that on 2 day of March (year) 2022 at [REDACTED] (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

the concrete from driving on the rotors of the vehicle in which was tracked from NE 40th ST of N Dixie Hwy, to Ne 34th ST of N Dixie Hwy Oakland Park Fire Rescue who was first on scene removed the occupant driver from the vehicle and placed her in their truck to evaluate her I made contact with the owner of the vehicle who was later identified as Amanda Martinez, who was medically evaluated by Oakland Park Fire Rescue, however she refused treatment and transportation During that time I smelled a weak odor of an alcoholic beverage that emitted from her breath While Amanda was standing, she was unable to keep her balance I advised Amanda than the traffic stop was over and that I changed hats and will conduct a DUI investigation in which she acknowledged

I spoke to Amanda and asked her, "Where were you going?" she advised that she was going to Pompano Beach Amanda also advised that she was currently in Hollywood, FL and was going to her friend s house It should be noted that she was currently in Oakland Park FL I asked Amanda to step aside from the side walk so I can conduct a DUI investigation in a dry well-lit area, in which she acknowledged and complied I asked Amanda medical questions such as if he has, medical issues, and physical defects, or recent surgeries in which she advised that she had an ingrown cyst that she had surgery on her armpit and that she wears glasses because she is far-sided Amanda agreed to perform roadside sobriety exercises which was captured on my BWC

Horizontal gaze nystagmus 2 out of 6 clues (lack of smooth pursuit, in both eyes only in his right eye Amanda had a hard time following instructions about using her eyes only, because she began to fall asleep

Walk and turn test 4 out of 8 clues (started too soon, missed heel-to-toe, stepped off
