 On 3-7-2022 at approximately 0054 hours, Tampa Police Real Time Crime Center indicated there was a hit on a stolen vehicle, a gray 2020 Jeep Gladiator NY JRR5609. The vehicle was reported stolen on 3-3-2022 from Tampa International Airport (#2022-00246). Officer J. Baar observed the vehicle pull into the parking lot of 3447 W Kennedy Blvd and made contact with the occupants. Defendant MARTINEZ was sitting in the front passengers seat of the vehicle. All occupants were removed from the vehicle. During an inventory search, MARTINEZ's purse was sitting on the front passengers seat. Inside there was a clear plastic bag with a white powder substance weighing approximately .01 grams. The substance field tested positive for cocaine.
