She was traveling north on Ebsenburg and made a left turn onto Tampa Palms, nearly striking a marked Tampa Police vehicle that was traveling on Tampa Palms. A traffic stop was made and upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, a strong odor of an alcoholic beverage, unsteady stance, and an admission to consuming alcohol (three whiskey drinks). The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later submitted to a breath test which had a BrAC result of .197 and .191. The defendant was identified by her FL DL.
