The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 The defendant was operating a 2017 Nissan Altima, FL Tag NKBV52, and was the sole occupant of the vehicle. The defendant was observed by your affiant driving the wrong way (E/B) on Cleveland St at Howard Ave, which is a one-way (W/B only) street. A traffic stop was conducted at Howard and Kennedy Blvd in the Circle K gas station parking lot.

Upon contact with the defendant, I immediately smelled the distinct odor of an alcoholic beverage emitting from her mouth and I observed that her eyes were bloodshot and glassy. As I began speaking with her, the defendant made spontaneous utterances that she should not be driving and that she had too much to drink. I asked the defendant where she was coming from and she stated that she was coming from "SOHO", specifically "Bar Howard". I asked the defendant if she was willing to undergo field sobriety exercises and she agreed to do so.

The defendant's participation in Field Sobriety Exercises indicated numerous clues of impairment. See video for further details.

Upon arriving to CBT, the defendant refused to provide a breath sample after being read implied consent.
