Communications Center (LWRCC) dispatched me to a two-vehicle crash in the area of northbound Interstate 95 (State Road 9), exit ramp to Lantana Road. Dispatch advised me that a white Toyota Corolla and a Chevrolet Pickup truck were involved in the crash. I traveled to the above location and observed a white Toyota Corolla (with attached Florida tag: IXRA97) blocking the left turn lane on Interstate 95, exit ramp to Lantana Road. The Toyota Corolla had damage to the front portion of the vehicle. The Chevrolet pickup truck was in front of the Toyota Corolla (attached Florida tag: 065UCA). The Chevrolet pickup had damage to the rear portion of the vehicle. I spoke to the driver of the white Toyota Corolla and identified him by his D.O.B 07/08/1995 and name as Amir Aaqil Alli. Mr. Alli stated that he was traveling in the inside left turn when the driver that was in front of him "slammed on his brakes" resulting in a front to rear end collision. Mr. Alli was also involved in a second vehicle accident at the same location, where he backed up into a Road Ranger Truck that was assisting with traffic. While talking to Mr. Alli, I observed that his eyes were glassy and bloodshot. Mr. Alli was also walking back in forth. The driver of the Chevrolet pickup truck, which was identified by his Florida driver license (N-250-473-91-244-0) as John Michael Nixon, provided a sworn witness statement documenting what he had observed during the crash and what his interaction with Mr. Alli was like. Mr. Nixon would be able to identify the driver of the white Toyota Corolla as the driver and sole occupant that was driving the vehicle at the time of the vehicle accident. While talking to Mr. Alli, he had a hard time following my directions and I observed Mr. Alli had slurred speech. After the completion of my crash investigation, I informed Mr. Alli that I was beginning a criminal investigation for driving under the influence (DUI). I asked him if he was willing to perform voluntary roadside exercises and he refused. Taylor warning was then stated, and he refused again. I explained to him that a refusal to perform the roadside exercises would be admissible in court. Based upon the above information and the totality of the circumstances, I believed that Mr. Alli committed the offense of driving under the influence. Mr. Alli was placed under arrest at 10:01 AM and charged with F.S 316.193.1a DUI. He was secured inside of my patrol car and transported to the county jail. At the testing facility, I conducted a 20-minute observation period. At no time did he regurgitate or take anything by mouth. I then requested that he provide a lawful sample of his breath and he agreed. The first

breath test sample was .000 and the second breath test sample was .000. I then requested that he provide a lawful sample of his urine and he refused. Implied consent was read, and he stated he understood. He then agreed to provide a sample of his urine. The urine sample was collected by the breath technician Leahey ID # 19183 at 11:32AM. I then read Mr. Alli his Miranda rights from a constitutional warning provided by the BAT facility. He stated he understood his rights. Mr. Alli was transported to Good Samaritan Medical Center for Medical clearance. He was then transported back to the Palm Beach County jail where he was booked without incident.

The above incident occurred in Palm Beach County.

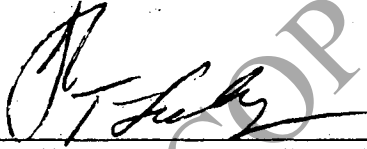

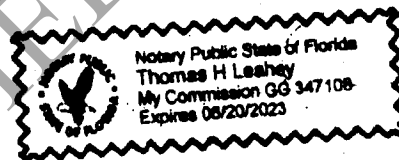
