#### Probable Cause

On the above date and time, I, Trooper Specialist J. Lampiasi, was parked at the Troop K West Palm Beach Station at mile post 94 on SR-91, Florida's Turnpike, in Palm Beach County, Florida. A white female, later identified via her FL DL as Amy Sundberg, drove up and parked next to my patrol vehicle on the passenger side. Sunberg tried to get my attention as she needed assistance trying to find out how to exit the service plaza. As Sundberg spoke, I noticed that her speech was thick and slurred. I observed her eyes were glassy/watery with ptosis. At that time I exited my patrol vehicle as I observed that Sunberg is showing signs of being impaired.

I asked Sunberg to exit her vehicle, which she refused to do at first. I then asked Sunberg for the keys to her vehicle and to shut the vehicle off. She could not find the keys within her purse. While speaking to Sunberg, I smelled the odor of an alcoholic beverage emitting from her breath and within the vehicle. At that time, I decided to reposition my patrol vehicle.

I requested Sunberg to participate in Standard Field Sobriety Tasks (SFST's), which she agreed. Sunberg finally stepped out of her vehicle and appeared uncoordinated and unsteady. Sunberg failed to cooperate unless I turned off my takedown lights. I advised her to turn the other direction, which she did. I gave the instructions for the horizontal gaze nystagmus. Sunberg would not cooperate with my instructions and would not follow the stimulus. I did observe that she was swaying side to side and forward/backward.

I then was beginning the instructions for the walk and turn. Sunberg refused to cooperate with my instructions on how to stand on the painted white line. Instead of listening to my instructions, she just started walking. She then advised she had a back injury. Sunberg would not cooperate with any SFST instructions.

I advised Sunberg that I would have to make a decision based on her personal interaction with me, which she disregarded. At that time, I advised Sunberg to sit back in her vehicle and provide me with her keys. I requested backup since she was being uncooperative as I decided Sunberg was going to be under arrest as soon as backup arrived.

Once backup arrived, I advised Sunberg that she was under arrest. As soon as I advised her, she started walking away from both the Deputy and I. We respectfully grabbed her arm so she could not run away. Sunberg started resisting us with tension and we need to steer her towards the front of my car to gain my control of her wrists. I placed handcuffs on Sunberg without any use of force with the exception of resistance control. Sunberg attempted to kick both of us but was unsuccessful. We walked Sunberg to the rear of my patrol car and attempted to place her in the rear seat. Sunberg would not get in the seat and resisted us. After a short time of trying to change the directions of her legs, she yelled out that she would sit down if she was asked nicely to sit down. I asked her to "Please" sit down, which she did.

After getting her in the sit, I closed the door and began speaking with the deputies. I heard Sunberg being uncooperative in the rear seat. The deputy pointed out that she managed to get her handcuffs off her wrist. We then took her out of the patrol car and asked her to turn the other way. She would not cooperate and first, but managed to listen to our commands shortly after. After correcting her handcuff's, I transported Sunberg to the Palm Beach County Jail. I advised dispatch that she was uncooperative and attempted to be combative.

While at the jail, correctional deputies met me outside to escort Sunberg as she was uncooperative previously. Sunberg was escorted into the DUI facility within the
