The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On July 12, 2022 at 1744 hours, FHP Communications received a call of a one vehicle roll over possible injury collision northbound I-75 (SR-93A) offramp to SR-618 (Selmon Expressway).

At 1800 hours I signed in service and advised I would be enroute as this was a high priority call due to being on the interstate and a rollover injury.

At 1827 hours, I arrived on scene. I observed a vehicle in the brush on its side. Several Hillsborough county deputies (#22-73095) were on scene along with an Aid car(E-37,R-37). The Deputies advised the driver was a possible signal 1 (Impaired driver). Deputies advised the driver had slurred speech and bloodshot and watery eyes. Deputies provided a note paper with the driver being identified as Amy M. Sacca (DOB 11-14-1975). Deputies advised they had two wheel witnesses with one still on scene.

I contacted the witness who advised Sacca was the driver. The witness advised the vehicle left the roadway with a large cloud of dust. He advised he approached the vehicle and observed Sacca as the only occupant in the vehicle. The vehicle displayed Florida registration Y92DFJ which returned to a 2009 white Ford Edge. The vehicle was registered to Sacca. I approached Sacca and asked her what happened. Sacca advised a vehicle swerved in front of her causing her to leave the roadway and crash. I could smell an obvious odor of intoxicants coming from her mouth. She was arguing with Fire and her speech was slurred. Sacca eyes were bloodshot and watery. Sacca had blood all over her face and arms. Sacca refused aid and signed a refusal form.

I informed Sacca that the collision investigation was over. Sacca was on her phone with her husband who she advised worked for the government. I informed her I was now switching to a criminal investigation for possible DUI. Sacca was informed her husband what was going on.

At 1844 hours, I read her Constitutional Rights off the FHP department issued card which she advised she understood. I asked who much alcohol she had to drink and she advised none. I asked if she would be willing to perform voluntary field sobriety exercise. Sacca continued saying, "I don't know." I asked her numerous times and she refused to provide a yes or no answer.

At 1847 hours, Sacca was placed into custody for DUI. Sacca was placed into the right rear of my vehicle. I asked Sacca if she would provide the breath sample which she refused.
