On 07/26/2022 at approximately 0330 hours, this Officer was traveling west bound on Northlake Blvd in the area of MacArthur Blvd, PBG, FL, when a vehicle was observed driving carelessly. Body worn camera and in car video were used. This Officer observed the vehicle, a red Toyota sedan (OGPP48/FL) traveling west bound in the middle through lane and unable to maintain a single lane. The vehicle drifted into the outside through lane three times and was traveling under the speed limit as well. Through a combination of vehicle pace and RADAR DSR2X (DB001317) front antenna (KC086606), this Officer observed the vehicle speed to be 35 MPH up to 40 MPH in a posted 45 MPH zone, with little to no traffic on the roadway. This Officer initiated a traffic stop on same in front of 4109 Northlake Blvd, PBG, FL and made contact with the driver who was the sole occupant. This Officer identified the driver via Florida Driver License photo, Andre Desouza (OF) while he was still in actual physical control of the vehicle. Desouza had glassy watery eyes, thick slurred speech, flushed red face to the extent of sweating, and the obvious odor of an unknown alcoholic beverage emanating from his breath at conversational distance. Desouza also appeared to have difficulty dividing his attention, this was noted because when Desouza was asked a question or when this Officer would say something to him, he would pause what he was doing to answer. Desouza also provided a current vehicle registration, then an expired version of same. Desouza also did not provide his proof of insurance until asked again by Ofc Lovett 523. Desouza had told this Officer he was coming from a friend's house on Federal and was on his way home. Desouza admitted to consuming two drinks on this night. Based on this Officer's observations, Desouza was asked to exit the vehicle to participate in Standardized Field Sobriety Exercises, to which he complied. Desouza appeared uneasy on his feet once he exited the vehicle. Desouza said he did not have

any medical conditions which would affect the exercises performed.

The first exercise conducted, was the Horizontal Gaze Nystagmus. The stimulus used was a Stylus Streamlight with an illuminated red tip. This Officer observed a lack of smooth pursuit in both eyes and sustained involuntary jerking in both eyes at maximum deviation. Desouza had a lack of convergence in his right eye on the first attempt and again in his left eye on the second attempt.

The second exercise conducted, was the Walk and Turn. The line used was a strip of yellow tape placed upon the pavement by this Officer. During the instructions, Desouza had difficulty remaining in the starting position. Desouza swayed and raised his right hand from his side. During the first set of steps, Desouza missed the line on the second step. After the final step, Desouza paused and asked for additional instructions. During the turnaround, Desouza kept his right hand raised from his side. During the return set of steps, Desouza again stepped off the line on his second step. Desouza also raised his right arm more than six inches from his side.

The third exercise conducted, was the One-Leg Stand. During the exercise, Desouza raised his right foot. Desouza swayed throughout the exercise and raised both of his hands more than six inches from his sides. Desouza placed his foot down once prior to being told to do so. Desouza had to be told to look down at his raised foot and count aloud.

The fourth exercise conducted, was the Finger to Nose. During the exercise, the following observations were observed: Desouza started the exercise prior to being told to do so. The first command of Left, Desouza touched under the tip of his nose, with the pad of his finger and had to be told to lower his hand. The first command of Right, Desouza touched the right side of his nose, then the tip of his nose with the pad of his finger and had to be told to lower his hand. The second command of Left, Desouza touched under the tip of his nose and had to be told to lower his hand. The second command of Right, Desouza used the pad of his finger and had to be told to lower his hand. The third command of Right, Desouza raised his left hand then corrected himself, touched the tip of his nose with the pad of his finger and had to be told to lower his hand. The final command of Left, Desouza touched under the tip of his nose, with the pad of his finger and had to be told to lower his hand.

Based on the results on this Officer's observations, Desouza was placed under arrest at 0347 hours. On the roadside, this Officer requested Desouza provide a breath sample for the purpose of determining its alcohol content, to which he refused. This Officer read Florida Implied Consent to Desouza, via Florida DOT Cards, to which he acknowledged and again refused at 0357 hours.
