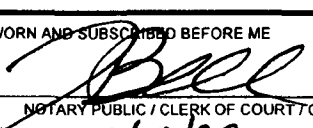
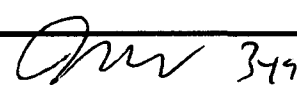


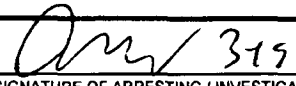

On Friday June 17th, 2022, at approximately 2222 hours I responded to the intersection of E Indiantown Rd/ N Alt Ala in reference to a traffic crash. I arrived on-scene and spoke with Ofc. Fandrey who advised he had completed his traffic crash investigation and found the driver of vehicle #1, Andrea Perugini (W/F 11/11/1973) at fault. I spoke with Perugini at the driver's window and immediately detected a strong odor of an unknown alcoholic beverage emanating from her breath and inside the vehicle. Perugini was asked to exit the vehicle and was extremely uneasy on her feet and used her vehicle as leverage as she exited. Perugini was advised by Ofc. Fandrey that he had completed his traffic crash investigation and found her at fault. I advised Perugini that I was going to be now conducting a criminal DUI investigation based on her being at fault for the crash, and showing multiple other signs of impairment such as the unsteadiness on her feet and strong odor of an unknown alcoholic beverage emanating from her breath. I read her Miranda Warnings from a pre-printed card to which she stated she understood. Based on the aforementioned events, I requested that Perugini submit to Standardized Field Sobriety Tasks to which she agreed too. During the SFSTs, Perugini stopped multiple times throughout the various tasks and began to cry and state that she made a mistake and should not have drove, however, never refused to continue to tasks at any point. She was also demonstrated/instructed each task and given the opportunity to ask questions and have each task shown again. The following are a summation of the SFSTs. HORIZONTAL GAZE NYSTAGMUS Perugini was unable to keep her head still during this task and had to be reminded multiple times to follow only with her eyes. -No resting nystagmus in either eye

-swaying Based on my investigation, observations, and totality of circumstances, I have probable cause to believe that Andrea Perugini was in actual physical control of a vehicle while under the influence of an alcoholic beverage, chemical, or controlled substance, to the point where her normal faculties were impaired, contrary to F.S 316.193. I placed her into handcuffs which were double-locked and checked for proper spacing per department policy at 2251 hours. I then transported Perugini to the Jupiter Medical Center for medical clearance. After being medically cleared, I requested that Perugini provide a breath sample. She originally agreed and shortly thereafter refused. I then read her implied consent from a pre-printed template, she stated she understood and would submit to a breath test. I then transported Perugini to the Palm Beach County Breath Alcohol Testing center, arriving at 0053 hours. I placed Perugini under a 20 minute observation period, during which she neither consumed nor regurgitated anything. We then went on video with BAT technician Bell#8656. I again requested that Perugini provide a breath sample. She agreed and provided two breath samples of .152 and .156. Post Miranda, she stated that he had been drinking a few glasses of wine somewhere in Tequesta. I placed Perugini in holding while all necessary paperwork was completed and subsequently booked her into the Palm Beach County Jail. She was given a criminal court date of 07/20/2022, 0830 hours. The above incident was captured on BWC. This narrative is a summary of the events and not purported to be verbatim.
