The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was driving a black 2018 Kia Rio (FL Tag #0896VP) eastbound on Fowler Av E, when she stopped in a left turn lane and randomly reversed her vehicle, almost striking a car behind her. She then drove forward and made a U-turn, heading westbound on Fowler Av E when she failed to stop behind a stopped the victim's black 2005 Honda (FL Tag #B8RYL). At the time, the victim was stopped at a red light (no improper driving) and was struck from behind at approximately 30 MPH. The accident resulted in approximately \$2,500 in damages and no injuries to either party.

During the traffic crash investigation, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, droopy eyelids, blank/dazed stare, slurred speech, poor balance, sluggish/lethargic appearance, slow/deliberate movements, confusion about the events that occurred during the crash, she admitted to drinking "1 beer" at the World of Beer (across the street from our location), admitted (post Miranda) to taking several medications prior to driving (Alprazolam, Lexipro, Topiramate, and Buspirone), and emitted a distinct odor of an alcoholic beverage from her breath.

The defendant was arrested for DUI crash following a poor performance on SFSEs and was taken to booking.

While at CBT, the defendant willingly submitted to a breath test and provided 2 samples measuring .023/.025 BrAC. Due to her usage of medication and because her breath test results were not consistent with her level of impairment, I requested a urine sample. She willingly provided that sample at 2115 hours.
