Art 1 § 16(b) On 07/20/2022 at approximately 12:00hrs I responded to the Dunkin Doughnuts parking lot located at 6919 SW 18th St. Boca Raton, FL. 33433 in reference to delayed domestic incident. Upon my arrival with D/S Udell I made contact with victim Stephen Sharon who told me the following and he later completed a sworn written statement: Earlier today I had a verbal argument with my wife Andrea Sharon about me not helping her with our five-month old baby boy. During the argument Sharon hit me in my face with her hand causing me to bleed. While speaking with Stephen I observed a small cut above his right eye. He told me due to Sharon hitting him with her hands caused the injury to his face. Stephen refused medical treatment while on scene. I asked Stephen was he in fear for his life and he stated "no I am just in shock that my wife hit me". Stephen also disclosed he has been having material issues with his wife and recently have been going to couple's therapy with his wife. I then relocated to the residence located at 6773 Via Regina and made contact with Andrea Sharon and she completed a sworn written statement and told me the following: I had an argument with my husband in the upstairs hallway of the home. The argument was about him not helping with daily child care of my son and Santiago being hot from sitting inside my car. I assured Stephen that Santiago was not harmed and he was well. Stephen got close into my face while we were arguing and I accidentally hit him in the face with my hands. Sharon also disclosed she was in fear of retaliation from Stephen after the physical altercation between. Stephen continued to verbally argue with Sharon after she left hallway into a guest bedroom. During my interview I made contact with Rose Valencia Castillo who resides inside home and she completed a sworn written statement and told me the following: Rose was inside the baby's room with Santiago while the physical altercation happens. She does not witness the incident and did hear her sister and brother-in-law arguing. After the incident happened her sister told her that it was accident when she hit Stephen in the face. The baby was not present in the same room or harmed during the physical altercation. Based on my investigation and the statements provided by all parties involved I found probable exist for an arrest. Andrea Sharon to be in violation FSS 784.03 1A1 domestic battery. Handcuffs were placed on both her hands and checked for fit. She was later transported to Palm Beach County Jail for further processing.
