The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On 06/12/2022, at approximately 0211 hours, Deputy C. Claridy (ABN 260034) arrived at Town Center Blvd / Brandon Pkwy, in reference to a person down call. The comments of the call advised a person appeared to be "passed out" in a black Toyota Tundra. Deputy C. Claridy observed a black Toyota pick-up bearing FL tag GTSE80 (VIN: 5TFRM5F18CX045224) at the above listed intersection. Deputy C. Claridy observed the defendant unconscious in the driver seat. Deputy noted that the vehicle was on and the vehicle was in drive. Deputy C. Claridy announced himself and was able to awaken the defendant. The the defendant regained consciousness, Deputy C. Claridy asked the defendant if he needed medical attention, and the defendant refused to be medically evaluated. Deputy C. Claridy noticed indicators of impairment during his interaction with the defendant. The affiant responded to the scene, observed the defendant to have watery/glassy eyes, bloodshot eyes, he was unsteady on his feet, and detected the distinct odor of an alcoholic beverage emanating from his breath. The affiant requested the defendant perform Standard Field Sobriety Exercises (SFSES) which the defendant agreed to perform. During the exercises, the defendant showed multiple signs of impairment and was subsequently arrested for DUI. The defendant agreed to provide a lawful sample of his breath to determine his breath alcohol content (BrAC). Breath Technician J. Piercy (ABN 4553) provided me with the BrAC results and they are as follows: First BrAC sample .149, Second BrAC sample .138. The defendant was identified via FL DL. The defendant was issued a DUI citation (AFYJT6E) which reflects the charge.

Pursuant to Florida Statute §92.525 and under penalties of perjury, I declare that I have read the foregoing document and the facts stated in it are true to the best of my knowledge. For Notices to Appear, I also certify that a complete list of witnesses and evidence known to me is attached.
