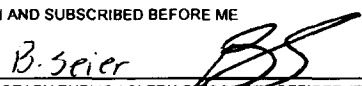

P R O B A B L E	The following incident was captured utilizing my department issued BWC. On Wednesday November 23, 2022 at approximately 2236hrs, I responded to the area of Stadium Grille 1203 Town Center Dr Unit 113, in reference to a battery. Upon arrival, I made contact with the victim, Scott Allen (WM 4/20/1959) who provided the following statement:						
	Allen was working as an Uber driver and picked up two subjects, Andrew Hackett II (WM 5/6/90) and his father, Andrew Hackett (WM 5/28/54) from Town Center, in Jupiter. Hackett Jr entered an address into the Uber app that was out of South Carolina, Allen advised him of such and that he could not drive him to South Carolina. Allen advised he would take the subjects to Hackett Sr's address in Tequesta, and they agreed. Once Allen began to drive, Hackett Jr began to berate Allen and was acting belligerent in the vehicle. Based on how Hackett Jr was acting, Allen refused to drive them any further, and dropped both subjects off near Stadium Grille.						
	As Allen was dropping them off, Hackett Jr began punching Allen on the side of the head (approximately 6 times) from the back seat. Hackett Jr and Hackett Sr exited the vehicle and began to walk away. Allen visually identified Hackett Jr, who was still standing in the area. Allen advised he wished to press charges.						
	I spoke with Hackett Jr, who was uncooperative with me. I asked about the incident that just occurred in the Uber and he stated he was not in an Uber. It was apparent that Hackett Jr was extremely intoxicated, as he could not find his ID when it was in his wallet, he was severely slurring his words, he was unsteady on his feet, and I could smell the odor of an unknown alcoholic beverage emanating from his person. I had to ask Hackett Jr numerous times for a form of identification and to explain what happened. He would not provide information about the altercation in the Uber and continued to be

uncooperative. I stated the facts to Hackett Jr, that he and his father had just been picked up in an Uber and dropped off. I asked Hackett Jr if this was correct and he stated it was. I again asked about the altercation that ensued inside the Uber and he advised he was never in an Uber and did not know what I was talking about. Based on the above statements and as a result of my investigation, probable cause has been established to arrest Andrew Hackett Jr for Simple Battery (Touch or Strike) pursuant to F.S.S. 784.03(1)(A)(1) as Hackett Jr did intentionally strike Allen in the head approximately 6 times. Allen did not sustain any significant injuries, and refused medical treatment. Hackett Jr was taken into custody and transported to PBCJ. Photos were taken of Allen and submitted to JPD Evidence.com.
