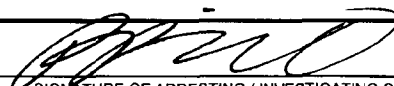

Officer Waltenburg told Fairbanks he has been trespassed from this location for 6 months. Fairbanks advised he would go home and left the area. See cad #22203658. I remained on the property and approximately 10 minutes after Fairbanks was given the trespass warning he returned to the property. Fairbanks was arrested for trespass after warning pursuant to Florida State Statue 810.09 (2) (B) . I placed Fairbanks into handcuffs, I double-locked them, and I placed him in the back right seat of my patrol vehicle. Fairbanks was transported to Jupiter Police Department for booking and processing. He was then transported to Palm Beach County Jail without incident. My department-issued Axon BWC was utilized during this investigation.
