On 02-22-22, at 2032 hours, Deputy Hansen #259008 responded to a call for service involving a motorist possibly asleep at a traffic light, at Selmon E U.S. Highway 301 Ramp / S U.S. Highway 301. Deputy Hansen observed the defendant sleeping in the driver seat of a Honda Civic bearing FI tag DCT6946 (VIN 2HGFC2F57JH599915). The vehicle was running, in drive and the defendant had her foot on the brake. Deputy Hansen made contact with the defendant and observed her displaying indicators of impairment. I observed the defendant displaying bloodshot glassy eyes, slurred speech and I detected the odor of an alcoholic beverage emanating from her breath. The defendant performed field sobriety exercises and impairment was detected. I arrested the defendant for DUI and she provided two lawful breath samples, (.228) and (.229) after a twenty minute observation period. I identified the defendant via her Washington drivers license.
