PERSONAL CONTACT

DRIVING PATTERN: Actual physical control (physical evidence or statements putting def. behind wheel of vehicle)

I was conducting traffic enforcement in the 2300 block of North Dixie Highway in the city of Lake Worth Beach, Palm Beach County, Florida, when I observed a sedan driving northbound on North Dixie Highway at a speed I visually estimated at 60 MPH in a 35 MPH. It was the only vehicle on the road. I activated my front radar antenna and obtained a clear Doppler tone and a reading of 57 MPH. I made a U-turn and caught up with the car that was identified as a Nissan Altima bearing Florida tag DDNY58. I shortly paced the vehicle with my car at approximately 55 MPH and I initiated a traffic stop by turning my blue and red emergency lights on. The vehicle came to a stop by crossing the double yellow lane and stopping in the left turning lane of Southbound Dixie Hwy. The driver and only occupant identified herself as Angela Valle but was unable to provide her driver license. Valle was the second registered owner of the Nissan.

OBSERVATION OF DRIVER:

Valle had bloodshot and glassy eyes. Her speech was slurred and an obvious odor of unknown alcoholic beverage was coming from her person. I did not notice any fumbling when she was looking for her license. Once asked to exit her vehicle, the odor of unknown alcoholic beverage followed her and became stronger when she talked.

DRIVER'S STATEMENTS:

Valle stated she drank two cocktails at approximately midnight.

ODORS:

Obvious odor of unknown alcoholic beverage that become stronger when she talked.

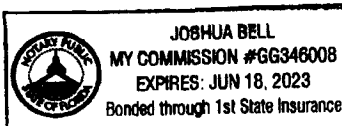

WALK & TURN:

Valle choose to perform the task bare foot. She was unable to maintain the instructional stance. She started before being told. She did not walk heel to toe on every steps. She used her arms to balance. She took 12 steps forward and did not turn as instructed. She then stopped and asked for instructions. On the walk back she again used her arms to balance, did not count out loud and did not walk heel to toe.

ONE LEG STAND:

Valle started before being told. She lowered her leg to the ground at her count of 1024 but did not resume the task. She also double counted multiple numbers.

FINGER TO NOSE:

Valle used the pad of her finger on all tasks instead of the tip. On task 2 she touched her upper lip, on task 3 and 4 she touched her septum. She swayed during the task.

ROMBERG ALPHABET:

For the Romberg alphabet, Valle was unable to recite it despite trying multiple times.
For the Romberg balance, Valle stopped the 30 seconds count at approximately 20 seconds.

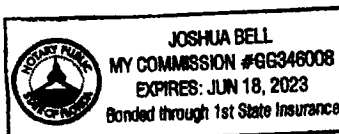

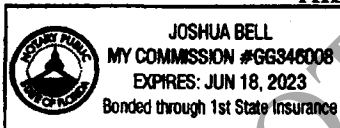

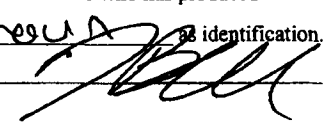
