The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 12/19/2021, at approximately 2253 hours, the defendant was operating a silver Honda Pilot, bearing FL tag LNTH65 (Vin: 5FNYP5H32KB027220) that was parked at the stoplight located at N Dale Mabry Hw / South Village DR. The defendant was the sole occupant of the silver Honda Pilot and was observed by the affiant sleep behind the wheel while the vehicle was running. As the defendant woke up she was asked if she needed medical attention which she denied. The defendant was confused and disoriented, I asked the defendant to step out of the vehicle and observed her to be unsteady on her feet. I then asked the defendant to stand in front of my patrol vehicle, while speaking to her I observed her to have glassy eyes, slow/lethargic movements and the distinct odor of an alcoholic beverage emanating from her breath. The defendant was asked to participate in the Standardized Field Sobriety Exercises, to which she agreed. During the exercises, the defendant showed further signs of impairment and was placed under arrest for DUI. Inside the Defendant's vehicle, a 50 ML Tito's Vodka was found empty on the passenger floorboard. The defendant was transported to CBT where she refused to provide lawful samples of her breath after implied consent was read and understood. The defendant was positively identified via an FL ID card. The defendant was given a Uniform DUI Citations AFHD18E.
