The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was operating a black 2022 BMW 330i, 4 door, Florida tag 63ALAH. The defendant drove in a manner in which the vehicle was weaving in the travel lane, with the left and right side tires crossing onto the outer painted lane markers numerous times. The defendant made a wide right turn and straddled a solid white painted lane marker briefly. The defendant approached a steady red traffic light where there is signage indicating "no turn on red". The defendant disobeyed this traffic control device and made a right turn while the traffic light was steady red. A traffic stop was conducted. The defendant had a distinct odor of an alcoholic beverage coming from his breath. The defendant's eyes were bloodshot, glassy, and watery. The defendant's speech was low and moderately slurred. The defendant displayed cognitive problems as he had to be reminded for the vehicle registration. The defendant stated he drank one beer tonight, and during the initial phase of this traffic stop he allowed his female passenger to answer for him. The front right side of the defendant's white shirt was soiled with food recent food stains. The defendant was mildly unsteady exiting the vehicle, and he swayed mildly while standing. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and based on a totality of the circumstances he was arrested for DUI. The defendant provided breath samples of .130% BrAC and .133% BrAC. The defendant was positively identified by his Florida DL.
