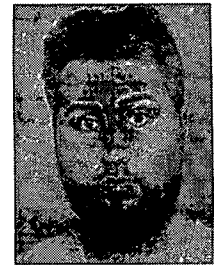

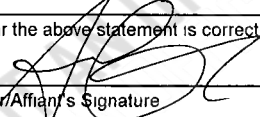
Probable Cause Affidavit

Before me this date personally appeared GUERRERO AARON (17796) who being first duly sworn deposes and says that on 13 day of April, (year) 2022 at [REDACTED] (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

To wit The victim advised she was in her daughter bedroom when the defendant stormed in, in which the two started to have a verbal altercation in front of their daughter, over the victim possibly cheating with another male, and moving out of state The victim advised the altercation then escalated in which the defendant grabbed her by the hair and threw her down on the bed. The victim advised a tussle then ensued in which she slapped him in the face (left side) and the defendant grabbed her by the left arm, snatching her cellphone away The victim advised she then called 911 from her daughter's cellphone The victim was observed with minor bruise under her left arm. BSO Fire Rescue refused

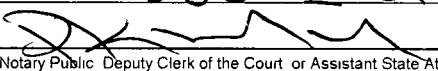
Based on the victims and witnesses` allegations, sworn statements, and injuries observed, my investigation revealed that a physical altercation occurred, and that the defendant did batter the above victim, who was the primary aggressor The defendant was charged with 1 count of Domestic Violence Battery per FSS 784 03-1A1 (HG) and transported to BSO Main Jail

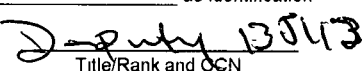

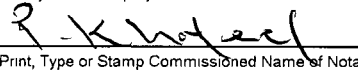
