The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On 12/17/21, at approximately 2345 hours, in front of 3402 Tindale Rd, Plant City, FL, the defendant was involved in a verbal dispute with Witness 1. Affiant observed the defendant standing the roadway in front of the listed address, screaming at the witness. The defendant showed clear and obvious signs of alcohol impairment, to include slurred speech, stumbling while walking and a strong odor of alcoholic beverage on her breath. The defendant continued to scream and approached affiant in an aggressive manner directing her finger in close proximity to affiant's face. The affiant repeatedly gave loud verbal commands for the defendant to step back and stop screaming. Neighbors from nearby houses came outside due to the defendant's loud screaming. The defendant continued to scream and act in an overt and aggressive manner toward the affiant. When affiant attempted to place defendant in handcuffs, the defendant struggled and pulled away from the affiant. The defendant continued to resist efforts to handcuff her. The defendant had to be forcibly escorted to affiant's patrol vehicle and had to be forcibly placed in the back seat of the patrol vehicle. The defendant was positively identified by her Florida Driver License.
