The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 05/08/2022 at approximately 0246 hours, a traffic stop was conducted on a silver 2020 Honda Accord with Florida tag QLBM63 at the intersection of Hillsborough Av W and Himes Av N after it was observed unable to maintain a single travel lane and was driving without headlights at night. Contact was made with the driver/defendant who was observed to have bloodshot/glassy eyes, dilated pupils, slurred speech, a noticeable sway while standing, and the odor of an alcoholic beverage coming from her breath. The defendant advised she was coming from a nearby club and had drank prior to driving. The defendant exhibited clues of impairment during SFSTs and was arrested for DUI. The defendant submitted to the requested breath testing which produced a BrAC of 0.284/0.293.

The defendant was positively identified via DHSMV photograph.
