The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was driving a silver 2018 Tesla Model S (FL Tag #02AYSI) northbound on Howard Ave N from Kennedy Bl W, when he rapidly accelerated and aggressively passed in and out of other vehicles. When I caught up to him, I was able to pace him at 65 MPH temporarily, before stopping at Cypress Av W at the red light. This section of Howard Av N has a posted speed limit of 40 MPH. As soon as the light turned green, it rapidly accelerated again, surpassing all other vehicles on the road at the time.

During the traffic stop for the speeding infraction and suspicious driving patterns, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, droopy eyelids, blank/dazed stare, slurred speech, poor coordination, he avoided eye contact while speaking to me, had poor balance, said he had nothing to drink and that he has taken several medications tonight, was in possession of a bar receipt form a few hours prior (4 Tito's Vodka drinks & 1 Michelob Ultra beer), and emitted a distinct odor of an alcoholic beverage from his breath.

Due to the totality of the circumstances, the defendant was arrested for DUI and was transported to booking.

While at CBT, the defendant was read Implied Consent and stated that he refused to take a breath test.
