The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did ON THE LISTED DATE AND TIME, CONTACT WAS MADE WITH D1 IN REGARDS TO A TRAFFIC CRASH WITH PROPERTY DAMAGES AND POSSIBLE INJURIES TO V1. ONCE CONTACT WAS MADE WITH D1, I IMMEDIATELY OBSERVED THAT D1'S SPEECH WAS SLURRED, THAT HIS EYES WERE GLASSY AND BLOODSHOT RED, AND THAT D1 SWAYED AS HE SPOKE TO ME. AS I CONTINUED TO SPEAK TO D1, HE SEEMED TO BE VERY REMORSEFUL OF HIS ACTIONS AND KEPT ASKING TO SPEAK WITH HIS BOYFRIEND AND ALSO KEPT ASKING TO GO HOME. WHEN IT WAS DETERMINED TO CONDUCT THE CRIMINAL INVESTIGATION, I REINTRODUCED MYSELF TO D1 AND ASKED IF HE WISHED TO PERFORM FIELD SOBRIETY EXERCISES. D1 REFUSED TO PERFORM WHEN ASKED 4 TIMES. AT THIS TIME, D1 WAS PLACED UNDER ARREST FOR DUI WITH PROPERTY DAMAGE (CITATION #ACHS17E) AND DUI REFUSAL (CITATION # AF50VQE.) D1 WAS THEN READ IMPLIED CONSENT PRIOR TO BEING TRANSPORTED AND REFUSED TO SUBMIT TO BREATH TESTING. AT THIS TIME, D1 WAS TRANSPORTED TO ORIENT RD JAIL. PROPERTY DAMAGES DURING THE CRASH WERE ESTIMATED AT APPROXIMATELY \$15,000. D1 WAS VERIFIED VIA THE ELVIS SOFTWARE.
